## 1. Promoter Details

## 2. Beneficiary

All proceeds raised from this raffle will be used solely to support the charitable activities and objectives of Lancashire TAAG. No proceeds will be used for private gain.

## 3. Eligibility

1. Entrants must be aged **16 years or over**.
2. Tickets must not be purchased by or on behalf of anyone under the age of 16.

## 4. Ticket Purchase

1. Tickets are priced at **£2.00 each**.
2. Payment must be received in full before tickets are entered into the draw.
3. No credit or unpaid entries will be accepted.

## 5. The Draw

1. The raffle draw will take place on **Saturday 27 June 2026** during the Lancashire TAAG Trail & Ale event.
2. Winning tickets will be selected entirely at random.
3. Ticket holders do not need to be present at the event to win.
4. Prizes will be awarded in the exact order that tickets are drawn:
  - The first ticket drawn will receive the top prize.
  - The second ticket drawn will receive the second prize.
  - This sequence will continue until all advertised prizes have been awarded.
5. Each ticket number may win only one prize. Once drawn, that ticket will be removed from the draw and cannot win again.
6. Prizes are non-transferable, non-exchangeable, and no cash alternative will be offered unless otherwise stated by the Promoter.
7. There may be restrictions and limitations on some prizes, for example;
